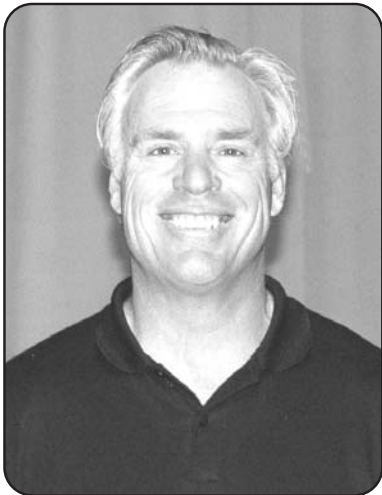

- Captain's test: Non-functioning tape recorders, test re-administered at great cost to the City

Attention!!!

Employee Health Premium Deductions

Beginning in Fiscal Year 2008-2009, employee premium co-payments will be deducted twice monthly, for a total of 24 deductions per year. Currently, employee co-payments are made on a biweekly basis, for a total of 26 deductions per year.

The first paycheck received in a month will have a premium deduction covering the first half of that month. The second paycheck received in a month will cover the second half of that month. There are two months each year in which employees receive a third paycheck in a month; there will be no deduction on that third paycheck. While the individual deductions will be normally higher, the overall annual deduction will be the same as there will be two fewer deductions.

FROM THE DIRECTORS ...

GASB/Pension

Non-Safety (Miscellaneous) employees have been negotiating with the City to obtain enhanced retirement benefits. Local 798 endorses this process. During the same time, negotiations also have been held between the City and all employee groups (including Local 798) to change health benefit requirements for all future employees hired by the City after July 2008 (these meetings were held as a result of GASB requirements that show the City has a potential \$4 billion unfunded liability in retiree health care over the next 30 years).

Neither set of meetings resulted in agreement between the parties. As a result, the employee groups and the City submitted separate and potentially competing ballot measures for the June 2008 election that address pension upgrades and Health System requirements. Both measures, to a different degree, include increased pension benefits and both measures address tightening restrictions for new employees to access the Health Service System. The sides have agreed to continue discussions until a February cutoff date to see if the parties can agree on one or the other ballot measure.

How does this affect firefighters (future, active and retired)? First, both measures include a cost of living enhancement which affects all City employees and retirees (miscellaneous and safety). The measures an increased compounded COLA without any complex formula that the Retirement Board must achieve (this is especially beneficial to Tier 2 retirees). Secondly, however, as an offset, newly hired employees (miscellaneous and safety) would work under a second "Tier 2": A health benefit with tighter restrictions to qualify and potentially paying into the Health system along with paying into the Retirement system.

More information will follow after the February deadline to amend or rescind these ballot measures.

Health Service System

Speaking of the Health Service System: The various health plans submitted their annual proposals to the Health Board in a November meeting. At the December meeting the Board reviewed the information and expressed its shock to the proposed increases by Blue Shield and PacifiCare. The Board voted to accept the Kaiser Plan and scheduled a January meeting to discuss the future of both Blue Shield and PacifiCare. The "City" plan will continue but the rate has not been set either. More information will follow.

Retirement Seminar

Due to popular demand another Retirement Seminar (for active employees) will be scheduled for this spring. Please look for the General Order announcing the seminar. Also, we are looking into formatting a "mid-career" seminar to assist employees to plan their future years far in advance.

Toy Program

As Chair of the Toy Program (and speaking for the entire Board of Directors) I want to thank all the active and retired firefighters who volunteered at the Toy Program this year (please read the Toy article). It would be impossible to continue without the benefit of your valuable time. It was a very successful year. And special thanks to Sally and all her crew at Santa's Workshop.

As always, Happy New Year to my mentor, Pete Sorensen. ✂



FROM THE DIRECTORS . . .

FOURTEEN DAYS IN DECEMBER

A lot can happen in two weeks. On December 6th a meeting was convened at City Hall. In attendance were Mayor Newsom, Chief Joanne Hayes-White, Fire Marshal Barbara Schultheis, Captain Bill Mitchell from BFP Plan Check and Isam Hasenin, the Director of the Department of Building Inspection. For the past several months there had been an ongoing project to

analyze the efficiency of the Department of Building Inspection. Members of the Bureau Fire Prevention had been active participants in the project and had been providing suggestions on how to better provide services for the contractors, builders and citizens of San Francisco.

The Plan

Director Hasenin presented his plan for streamlining the building permit process. He proposed transferring all the new construction and remodel plan review along with the inspection functions of the Fire Department that were currently under the Fire Marshal's office into the Department of Building Inspection (DBI). This meant that the positions, budget and revenue that were currently controlled by the SFFD would be moved. Not only did he want to transfer the fifteen Bureau of Fire Prevention members assigned to plan check and review, but he also wanted control of the sixteen BFP members that were assigned to district inspections. In addition he proposed taking control of the plan review and inspection functions that the SFFD provided to both the Port and the Airport. That meant another five members of the BFP would now be working for DBI.

Meet and Confer

The SFFD had been ambushed by another city department. At no time during the efficiency study project had there been any mention or proposal of taking fire department employees. Some consideration was being given to the elimination of possible redundant activities and everyone felt that progress was being made. There had been no meet and confer with labor concerning this obvious change in working conditions and promotional opportunities. Bill Mitchell left the meeting with a distinct impression that the transfer was a "done deal".

Local 798

On December 7th, Local 798 was made aware of the raid that had been perpetrated against its members. Apparently prior to being appointed Director of DBI, Mr. Hasenin had worked in San Diego for a building inspection department

where San Diego Fire Department fire inspectors had been transferred into the building department.

The Executive Board of Local 798 met on December 11th and prepared a motion to spend \$30,000 to save the jobs that were going to be transferred. In addition a fact finding team was authorized to determine what had happened in San Diego. On behalf of the Union, President John Hanley sent a letter to Mayor Newsom expressing the disappointment of not being included in discussions that affected working conditions. At the Union Membership meeting on December 13th, the members not only unanimously approved the motion for funds, but increased the expenditure to \$50,000. Over the course of two days, President Hanley had communications with both the Mayor's Office and the Chief's Office that would be described as "lively".

Fire Commission

The Fire Commission met on the evening of December 13th and was made aware of the proposed take-over by both President Hanley and Director Brendan O'Leary. Chief Hayes-White also briefed the commissioners during her scheduled report. The DBI proposal was not on the agenda, but Vice President George Lau sought advice from the Assistant City Attorney as to what action the commission could take to voice their concerns regarding this unilateral plan. The Assistant City Attorney offered an opinion to President Paul Conroy that a letter could be sent on behalf of the Commission.

San Diego

Lieutenant Joe Cuff (BFP supervisor of district inspectors), Bill Mitchell and Brendan O'Leary met with the Assistant Fire Marshal and Fire Marshal of the San Diego Fire Department on December 17th and 18th. They also met with a director of the San Diego Firefighters Local. A Memorandum of Understanding dated May 25, 1999 did transfer fire inspectors to the building inspection department. It was a time during a budgetary setback that it was advantageous for both departments. But times have changed. The Fire Marshal and Assistant Fire Marshal both expressed a desire to transfer the fire inspectors back to the Fire Department. The San Diego Firefighters Union also sees a benefit having the inspectors back under the authority of the Fire Marshal.

Building Inspection Commission

The Building Inspection Commission meeting convened at 9AM on December 19th at City Hall. Something had obviously happened since the original transfer proposal. Mayor Newsom was in attendance and voiced his support for the efforts of everyone that had been involved in the efficiency study, but he emphasized that moving forward must be a collaborative effort by all the departments involved. He specifically mentioned that the culture of the Fire Department must be respected.

John Hanley, BFP Captain Tom Harvey, Brendan O'Leary, Inspector John Darmanin, Lieutenant Mark Hayes and retired BFP Captain Mario Ballard all addressed the Commission and spoke in support of the services provided by the SFFD regarding plan review and inspections.

COAST GUARD DENIES CALLING OFF S.F. FIREBOAT RESPONDING TO SPILL

A U.S. Coast Guard commander disputes claims by Mayor Gavin Newsom and other city officials that the agency unilaterally canceled the response of a city fireboat to this month's oil spill in the bay, saying the decision was made by the San Francisco Fire Department.

Meanwhile, city officials acknowledged that the fireboat never actually left the dock the day it was dispatched to the spill, despite the officials' earlier assertions that the boat was en route to the disaster when it was turned away by the Coast Guard.

"We never directed them and said 'No, don't get under way,'" Coast Guard Cmdr. Jon Copley said Wednesday. "They would have been more than welcome. If they had already been under way, they would have been in the vicinity of the Bay Bridge. We could have directed them to check out the damage."

The conflicting accounts about the fireboat's aborted response in the hours after the container ship Cosco Busan sideswiped the Bay Bridge on Nov. 7 are significant because the boat crew stationed on the city's waterfront could have provided an additional set of eyes as 58,000 gallons of bunker fuel oil spilled into the bay.

The Coast Guard says it didn't realize the magnitude of the spill for about eight hours after the ship hit the bridge at 8:27 a.m. Once the agency finally grasped the magnitude of the incident, an additional four hours passed before the public was notified that the spill totaled 58,000 gallons rather than the 140 gallons the Coast Guard had been reporting all day.

Newsom testified on Monday before a House subcommittee investigating the spill and expressed frustration that the fireboat had been turned away by the Coast Guard. He indicated that the boat was on its way to the scene of the disaster when it was sent back to shore.

"Our fireboat dispatched within the hour from Station 35 under the Bay Bridge to help assess damage, but returned to the dock after the Coast Guard notified us that there was no fire or injuries and expressed concern for safety of the fireboat due to the foggy conditions," he said in his written testimony.

Similarly, the mayor told reporters last week, "We had a fireboat out there within an hour. They were told to turn around, that 'No, no, we don't need you.'"

But Copley said Wednesday that, in the hour after the ship crash, the Coast Guard received a call from city Fire Department Lt. Kyle Merkins asking whether the agency needed help rescuing people from the water.

Copley said the Coast Guard advised Merkins that search and rescue aid was not needed but never said the fireboat should not follow through with the call from local dispatch operators sending it to the scene.

"When (Merkins) called ... we still didn't know there was oil being leaked. ... We said, 'No, we don't need assistance for search and rescue,'" Copley said. "He called back to his dispatch and said ... 'They don't need rescue assistance,' and he told them not to come."

Fire Chief Joanne Hayes-White disagreed with the Coast Guard's assessment of the conversation, which took place on a cell phone and was not recorded.

"It sounds like his perspective is a little bit different from

ours," she said, meaning fire officials took the conversation between the Coast Guard and Merkins to mean the fireboat crew's assistance wasn't needed in any way.

The fire chief also suggested her department never meant to indicate to the mayor or to the general public that the fireboat had left its dock and was sent back.

"It's kind of a semantics thing," she said. "From a dispatch point of view, we were dispatched for all intents and purposes, and we were planning on responding to the incident."

Hayes-White acknowledged that, although the fireboat is not equipped with booms to contain the oil and crew members are not trained to handle oil spills, the crew's arrival on scene could have meant that city officials had a better understanding about the spill's magnitude early on.

According to the fire chief and 911 dispatch recordings released by city emergency officials Wednesday, the Fire Department learned about the container crash only after a former fireboat pilot who was boating in the bay called the fireboat crew to alert them about an hour after the incident occurred.

In the aftermath of the crash, city officials have complained repeatedly about the lack of information from the Coast Guard.

The conflicting accounts about what led to the fireboat crew's decision not to proceed to the scene further underscores breakdowns in communication between federal and local authorities on Nov. 7.

And Newsom's assertions to reporters and subsequently in testimony to the House subcommittee that the fireboat had left its dock in response to the crash raises questions about communication up and down the chain of command among city officials.

Newsom spokesman Nathan Ballard said the mayor's testimony before the House subcommittee Monday "accurately reflects what he was told by the fire chief."

The audio recordings of the fireboat's dispatch - released by the city's Department of Emergency Management to The Chronicle in response to a request under the California Public Records Act - confirm that the Coast Guard never directly contacted local emergency personnel to alert them of the crash. The recordings also don't reflect the agency asking the fireboat crew to cancel its response.

During a 9:30 a.m. phone call between a Fire Department dispatcher and the Coast Guard communications center on Yerba Buena Island, the fire dispatcher seemed puzzled that a container ship could have crashed into the bridge an hour earlier and no one from the Coast Guard had called local officials to warn them.

"Our fireboat got a call ... that a ship might have struck the Bay Bridge," the fire dispatcher said.

"Yeah. We received reports at 8:30 of a ship making contact with the delta tower Bay Bridge," the Coast Guard dispatcher said.

"So that's an hour ago?" the fire dispatcher asked. "And did you investigate it?"

"We are investigating it right now," the Coast Guard dispatcher said.

"OK. I guess we're going to send a fireboat over there," the

FIRE DESTROYS FORMER S.F. HOME OF IRISH FRATERNAL ORGANIZATION

A piece of San Francisco history went up in flames Tuesday when a stubborn one-alarm fire destroyed the former home of an Irish fraternal organization.

The unreinforced masonry structure, on Mission Street between Seventh and Eighth streets, was so badly damaged that the city's Department of Building Inspection plans to issue a demolition order early Wednesday.

"The feeling is that it's better to knock it down before it falls down," said Bill Strawn, a spokesman for the building department. "The structure has been weakened to such a point that it could collapse at any time."

The fire at 1133 Mission St. was reported at 6:51 a.m. Tuesday and was still burning well into the night. Fire crews were pulled from the interior when the ceiling collapsed, but about 30 firefighters continued their water bombardment from the sidewalk and atop a ladder that hovered above the building.

The old brick structure was supported by thick wooden beams - perfect fuel to keep the building aflame. Firefighters periodically turned off the hoses throughout the day, but the flames kept coming back to life.

"We're going to be on the scene all night," said San Francisco Fire Department Lt. Ken Smith.

Crews kept the fire from spreading to the building next door - home to the local firefighters union.

One firefighter suffered burns on the neck, and a second was injured when the ceiling fell. They were treated and released, officials said.

Investigators have yet to determine the cause of the fire. Assistant Fire Chief John Lo said the building had been vacant and under renovation. Workers were last in the building at 10 p.m. Monday, authorities said.

fire dispatcher said.

"You're going to send a fireboat over there?" the Coast Guard dispatcher said. "OK. Yeah. Like I said, we don't know how much damage has been done."

Supervisor Ross Mirkarimi, who on Tuesday requested that the Board of Supervisors hold a hearing on the spill next month, called the revelations about the conflicting stories "very alarming."

"We need to understand where a breakdown in leadership occurred and whether there was any sort of cover-up so that this never occurs again," Mirkarimi said.

Board of Supervisors President Aaron Peskin, who has criticized Newsom for taking off on a Hawaiian vacation after the spill, said "there wasn't a sense of urgency by the administration" immediately after the incident occurred.

"It's not the end of the world if the fireboat went out or didn't go out," Peskin added. "It wouldn't have changed the fact that we had a massive oil spill on our hands. The problem is that not only did we not mobilize our own resources, but we then misrepresented for the public that we had done so." ✂

The one-block stretch of Mission was closed to traffic all day Tuesday. It is expected to remain off-limits at least through Thursday, or when the building is finally torn down, Strawn said.

The Municipal Railway's 14-Mission electric trolley has been rerouted around the scene, and a shuttle motor coach has been added to take people along segments of Mission.

The building is owned by the Knights of the Red Branch, an Irish fraternal organization, which planned to lease it to a Presbyterian church, senior building inspector Ed Sweeney said. Like many at the fire scene, he had a personal link to the building.

"My parents met there," he said.

During its heyday from the 1920s to the 1950s, the social club and dance hall served as a hub for the city's Irish community. Dances were held on Friday, Saturday and Sunday nights.

Tom Hayes, an Irish immigrant, met his future wife there around 1949. Tom and Patricia Hayes have been married for 55 years, said their daughter, Joanne Hayes-White, San Francisco's fire chief.

"There's a lot of history in that building," she said. ✂

State Fire Marshal and the Attorney General

Retired State Fire Marshal James McMullen spoke to the Commission and referenced a State Attorney General's opinion regarding the need to keep Fire Department inspection functions separate from the Department of Building Inspection.

The analysis stated:

"The function of the State Fire Marshal is to foster, promote and develop ways and means of protecting life and property against fire and panic."

"The State Fire Marshal, the Chief of any city or county fire department or district providing fire protection services and their authorized representatives shall enforce in their respective areas building standards related to fire and panic safety adopted by the State Fire Marshal."

"The division of authority for enforcement of building standards adopted by the State Fire Marshal shall be as follows:

Regarding Sections of the Health and Safety Code; as far as practical that the enforcement be carried out at the local level by persons who are regular full-time members of a regularly organized fire department and not be carried out by other persons pursuant to Section 34004 of the Government Code."

Support

Later during the meeting, Commissioner Michael Theriault who is also a member of the San Francisco Labor Council voiced an opinion that it was heartening to see that the BFP functions would remain under the authority of the Fire Department.

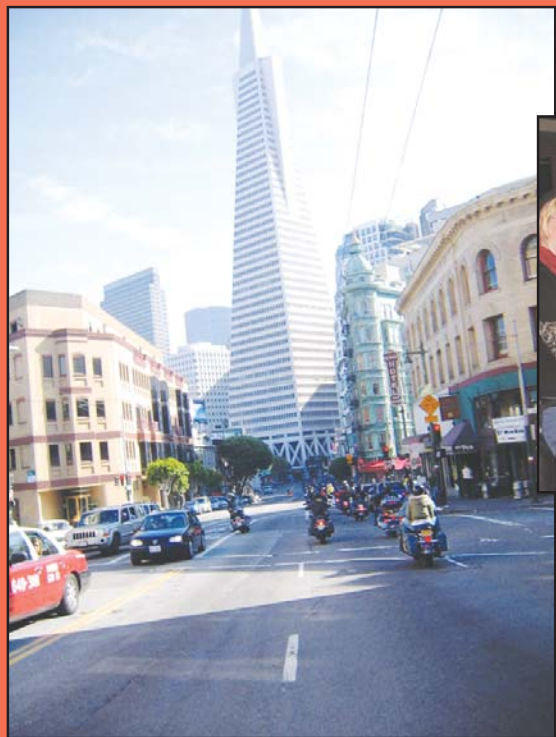
