

# LETTER FROM THE PRESIDENT



As dangerous as our occupation is, the summer of 2008 has just gotten much more dangerous. Since the beginning of June, there have been three separate instances where 5 engines have left the City and been deployed to fires throughout the State of California. The nature of these wildfires is something altogether different from our city fires, hence special training is necessary. Because of this training and experience we are able to defend other jurisdictions when these cities and towns come in danger from urban-interface fires. To all the brave men and women who have volunteered to spend weeks at a time away from your families fighting fires throughout the State of California, Thank You.

The State of California has reached a spending crisis which has affected the City budget. The Firefighters Union has done its fair share to help balance the City's projected deficit for this year and for the next two years as well. Congratulations to our members for assisting the City again.

Recently some of our members have come with Methicillin-resistant down Staphylococcus aureus (MRSA) or Staph Infection. Senate Bill 2754 will mean that this is a job-related, industry-inclusive disability. For those members who have contracted this debilitating condition (and it's difficult to clarify the exact instance that they were exposed to this infection) MRSA affects their home life as well as their job as a San Francisco Firefighter. With the future passing of SB 2754, MRSA will be considered job-related and they will be covered by CCSF. SB 2754 will be voted on in August. We are keeping our eyes on this to ensure its passage and we will keep you posted.

In October 2008, Director James Vannucchi will be organizing a Bocce Ball Tournament which will benefit the San Francisco Firefighters Cancer Prevention Foundation. Keep your eyes open for dates when teams may sign up.



GILLAM, James Haughton "Jim" – Born January 4, 1918; died peacefully on May 3, 2008 at the age of 90 following a short illness. He was born in San Francisco, and came of age in a city as few can remember it today. He watched the building of the Golden Gate Bridge and enjoyed athletic prowess during his teenage years, playing running back with the San Francisco's Mission High School Football Team. Jim was a Veteran of World War II. He served with the U.S. Army in constructing the Alaska-Canada (ALCAN) Highway and Canada (ALCAN) Highway and subsequently participated in the Aleutian Islands campaign against the Japanese. In 1946 Jim returned to his hometown and served with distinction for 28 years with the San Francisco Fire Department. He was known for his bravery and tempted fate on numerous occasions. Following his retirement from firefighting in 1973, Jim served as the Director of the San Francisco Retired Firefighters of Sonoma County and ran a small landscape contracting business. Jim enjoyed playing golf and cards with enjoyed playing golf and cards with his many friends. On the fairways, Jim achieved a 'once in a lifetime' experience of a hole-in-one on multiple occasions. His greatest passion was doing charity concrete work for those in need. He is survived by his wife of 61 years, Alice, of Santa Rosa, daughter Annette, and two granddaughters, Alexia and Annie of Santa Rosa, and son Andy and daughter-in-law Sally of Austin, TX, as well as two additional grandchildren and two great-grandchildren.

### THE VANNUCCHI PAPERS

Quite often we receive calls to the Union Hall from members who have questions as to their rights when it involves an on-duty criminal investigation or accessibility to their personnel files. Hopefully, this article will address those concerns.

Under the Firefighters Bill of Rights, firefighters who are subjected to questioning after a critical incident where severe injury or death arises from the performance of a firefighter's duties have numerous protections. These protections are very similar in content to the protection afforded peace officers under the Public Safety Officers Procedural Bill of Rights Act when they are under investigation for critical incidents or for an onduty matter that may or may not be criminal.

If you become the focus of an interview (don't be fooled, this is really an interrogation) when there has been a critical incident or if there is an inquiry into criminal activity, **DO NOT** discuss the matter or your conduct with an officer, a station steward or anyone other than an attorney or other person with whom you will enjoy a statutory privilege of confidentiality. Examples of other person(s) with whom you share a privilege include religious advisers, psychiatrists, psychologists and spouses.

If you do become involved in a critical and/or criminal incident, the very moment you are questioned about your conduct, you believe that you have become the focus of a criminal investigation or you are Mirandized, do not give a statement without first contacting a Union Official or an attorney.

As it pertains to your individual personnel record, the Firefighters' Bill of Rights again provides an array of protection. Initially, under the Code, no adverse comment can be placed in your personnel file without the firefighter being able to see and sign the instrument or initial that he/she refuses to sign the document. To simplify, this means any note, file or document generated by any supervisor for any personnel reason are all now personnel files and subject to review by the firefighter.

Secondly, the Code provides that firefighters have thirty (30) days within which to file a written response to adverse comments entered into a personnel file, and the written response by the firefighter is required to be attached to and accompany the adverse comment. This means that all firefighters within the State of California have the absolute right to inspect their entire personnel file, or any other file used for any personnel purposes, no matter how old these documents may be. The Code remains silent if a firefighter has the right to sign and respond to old adverse comments that pre-date January 01, 2008.

Additionally, the Code mandates that the employer must make personnel files available for inspection by firefighters, without retaliation, within reasonable times, on duty and without loss of compensation.

Protect yourself and your family by protecting your personnel records. Annually, inspect and confirm the contents of your personnel jacket. Obtain a copy of it and have it certified/acknowledged by the person providing it to you that it is complete. This will prevent documents being used against you that are outside the "official" personnel file maintained by your supervisor.

#### FROM THE DIRECTOR ...

In the past few issues I have written about Proposition B which was on the June ballot. I am please to inform our membership and retirees that Prop. B passed overwhelmingly by the voters.

Prop. B addressed many issues which included upgraded retirement benefits while tightening up the health benefit requirements for future City employees. For now, I'll only address the retirement benefit issues.

Beginning in 2009, the annual Basic Cost of Living Adjustment (COLA) will increase from up to 2% simple interest to up to 2% compounded interest. Also the Supplemental COLA will increase from a potential 3% compounded to 3 1/2% compounded (this is incremental in 1/2% increases: the COLA could be 2%, 2 1/2%, 3% or 3 1/2% -- All compounded.) The actual Supplemental rate will depend on the Retirement System's return of investment in that fiscal year.

These increased benefits are for both active and retired employees. Please give me a call if the above analysis confused you even more.

Please check your calendar for

some great events in the next few months. First, the last Local 798 "Day at the Races" at Bay Meadows is scheduled August 17, 2008, Second, a Chili Cookoff is scheduled September 13, 2008. Stay tuned for more details. Third, the annual Toy Program Golf Tournament is October 27, 2008. Please call the Toys to signup. Finally the first annual Local 798 Bocce Ball tournament is tentatively scheduled for October 10, 2008. Again, more information will be made available in the next months. Or call the Union for any questions.

all the benefits of due process. Secretary Frank Kelly was a great resource regarding Civil Service rules and Tom O'Connor was many times a voice of reason when we were looking for other opinions. ### CANCER PREVENTION FOUNDATION UPDATE

Much has been accomplished in the last year and a half. Our bladder cancer screening and study that was conducted last year was presented by Dr. Kirsten Greene in May at the Annual Scientific meeting of the American Urological Association in Orlando, Florida. We have received many inquiries from departments throughout the United States that are now concerned about their firefighters and the higher risk of contracting bladder cancer. Although our study found two retired firefighters with cancer (bladder, kidney), it also produced some false positives and one false negative. This raised a "red flag" with Dr. Stoller and Dr. Greene at UCSF. So our testing protocol will be changed to one that is much more definitive. We are hoping to offer this screening before the year is over.

In July we will be making a video that will be viewed by active firefighters during battalion-based training. It will stress the importance of using a protective breathing apparatus. We will also discuss our next screening which will take place starting in October. This year we will offer a self-administered colorectal screening to all active and retired firefighters 40 years of age and older and to any firefighter with a family history of colon cancer. Once again, the Department Administration has agreed to help our Foundation by paying for the lab processing of the tests.

There are many future studies that we want to conduct but there is a process we have to go through to bring these studies to fruition. Dr. Kirsten Greene and Dr. Judith Walsh are currently working on consolidating the data from our studies into a single application to UCSF's Committee on Human Research (CHR). Once we receive approval through this Committee we will be



on our way to the following voluntary programs:

- Blood draw for active firefighters every 2 to 3 years to test for any genetic changes
- Blood gas study to take place prior to and after working fires at designated companies
- Study looking into neurological degenerative diseases and brain cancer
- Ongoing screening for cancers of the genitourinary system

We will also look into and take advantage of any new testing procedure that will help our active and retired firefighters lead a healthier life. Our Foundation is at the point where we need a Project Manager for our studies. This person would be in charge of data input and coordinating efforts between UCSF and our Department. This is a very important position that we must fill.


Once again I highly encourage everyone to take advantage of what is going to be offered. This Foundation has been formed with your health and well-being as our number one goal.

Moments later, rescue units are rolling through the streets of San Francisco with lights flashing and sirens wailing. The reptilian part of the brain kicks in briefly allowing a momentary thrill as bystanders move back, traffic jerks aside and intersections clear.

"All units responding to 120 Hawn Street, CPR in progress," says the dispatcher.

OK folks; it sounds like the real thing. Get ready to dig in, click on, and work through this one. You begin to enter that zone where peril and miracle are one. And as you go the living is enormously interesting.

There are magic carpet riders in all places: maintenance engineers, car washers, waiters, waitresses, nurses, doctors, etc. At times they seem sort of rare, but you know them when you see them – basically because you feel good when you are in close proximity or with them.

We arrive at the scene and take over CPR begun by family members and start other life saving procedures. The Patient is bagged, placed on a monitor, an IV started, a tube dropped in the airway ensuring the delivery of 100% oxygen. Drugs are administered via IV and the Patient begins to respond. Now it's time to "chuck and truck" – off to the hospital with a patient who now has a pulse and a low blood pressure. Additional meds are administered in route to begin gradually bringing the blood pressure back up.

The physician at the receiving hospital is complementary of the rescuers because the patient, once in cardiac arrest, is now doing even better in the Emergency Room than she was at her house before the rescuers began transport.

"You guys really do a good job out there" one of the ER nurses says. And we all feel good and self assured. We thank her for saying so.

Then we return back to quarters to change into our Sunday's best because we now have to go downtown and answer to a false complaint drawn up by a spurious manager. We try to explain this to a higher up. But they seem disinterested and don't bother to listen. Then we get a letter in our file.


